### **ORDER:**

In the Government order first read above, sanction was accorded for continuance of 2 Special Circles and 7 Divisions consisting of 127 posts till March, 2015 to look after the works pertaining to Reconstruction and Jawaharlal Nehru National Urban Renewal Mission (JNNURM) Programmes and structural & Quality Control Wing surrendering 31 posts.

2. In the Government order second read above, sanction was accorded for continuance of 2 Special Circles and 7 Special Divisions from 01.04.2015 to 31.03.2016 totalling 127 posts to implement the works under JNNURM

Circle, Reconstruction Circle, Structural & Quality Control Wing and Rajiv Awas Yojana Programmes.

3. In the G.O. third read above, sanction was accorded for continuance of the 2 Special Circles and 7 Special Divisions consisting of 127 post from 01.04.2016 to 31.03.2018 to complete the spill over works under JNNURM, RAY Reconstruction works and the targeted works under HFA.

4. The Managing Director, Tamil Nadu Slum Clearance Board has stated that the Slum Free Cities Programme under Vision 2023 envisaging houses to 13.91 lakhs slum / poor families living in the urban areas of Tamil Nadu at a cost of Rs.97,752.99 crore before 2023 is under implementation as detailed below:-

It is proposed to resettle the remaining slum families in tenements out of funding assistance from external funding agency like World Bank under Tamil Nadu Housing and Habitat Development for Urban Poor Programme. The works are likely to be taken up shortly. The status of resettlement is as follows:-

Besides, reconstruction of the dilapidated tenements, repair and renewal works to tenements, maintenance of 1.60 lakh tenements and slum improvement works to raw slums are also under implementation.

5. The Managing Director, Tamil Nadu Slum Clearance Board has also stated that the various programmes of Tamil Nadu Slum Clearance Board are being implemented by 5 Circles and 21 Divisions (18 expenditure Divisions, 3 non expenditure Divisions). The following Circles and Divisions are functioning as permanent Divisions to implement the regular programmes of Tamil Nadu Slum Clearance Board.

8. The Managing Director, Tamil Nadu Slum Clearance Board has also stated that the project proposal for "Tamil Nadu Housing and Habitat Development for Urban Poor" has been sent to Government of India to seek World Bank funding assistance. The main components of the project are Urban housing investments, Technical assistance, Capacity building and Project Management. The objectives of the project include support for the resettlement and redevelopment, following best practices of relocation of families living in extremely vulnerable and high risk areas, piloting new models of affordable housing, integration of land use planning with housing and habitat development. The total Project Cost is Rs.4,647.50 Crores (USD 715 Million) with a World Bank loan of Rs.3,347.50 Crore (USD 500 Million), the remaining amount Rs.1,300.00 Crore (USD 215 Million) would be the counterpart funding from the State Government.

9. He has further stated that the World Bank team visited Chennai during 28.08.2018 to 04.09.2018 had discussions with the Government and informed to form the Project procurement Cell with dedicated procurement staff. To carry out the pre construction project planning activities and subsequent monitoring, a Project Monitoring Unit needs to be created in

Tamil Nadu Slum Clearance Board for this World Bank funded project, comprising of teams for Procurement, Environment Management, Project Implementation and Social Development. The Project staff positions on Project mode for the various activities to be carried out by Project Monitoring Unit (PMU) have been worked out and the details of staff required in various categories to implement the above said Project have been placed before the Board for its approval and the same was approved. The consolidated pay for the positions on contract are based on the PMAY HFA Guidelines, Contract Payment Structure of ELCOT, Daily Wages fixed by the Chennai District Collector and Standard Schedule of Rates of Public Works Department.

10. The Managing Director, Tamil Nadu Slum Clearance Board has further stated that the Board Members on Tamil Nadu Slum Clearance Board vide B.R.No.4.15 and 4.06/489, dated 14.11.2018 has approved the following:-

- (i) To continue the following:
  - (a) Existing 2 Special Circles and 7 Special Divisions as approved upto 31.03.2018 in G.O.(2D) No.40, Hg&UD Department, dated 26.03.2018 for a further period upto 31.03.2023.
  - (b) RAY Cell as HFA Cell till 31.03.2023 as approved in G.O(Ms)No.42, Housing & Urban Development (SC1(2)) Department, dated 22.02.2011.
- (ii) To create
  - (a) One more post of Chief Engineer for World Bank funded Tamil Nadu Housing and Habitat for Urban Poor Programme and other works in Chennai as in Annexure III.
  - (b) One Special Circle with staff for World Bank funded Tamil Nadu Housing and Habitat for Urban Poor Programme in Chennai as in Annexure IV.
  - (c) Two Special Divisions for implementing the World Bank funded Tamil Nadu Housing and Habitat for Urban Poor programme in Chennai as in Annexure V.
- (iii) Project Monitoring Unit (PMU) in Tamil Nadu Slum Clearance Board for the World Bank funded "Tamil Nadu Housing and Habitat Development for Urban Poor" Project in Annexure VI

11. The Managing Director, Tamil Nadu Slum Clearance Board has, therefore, requested the Government to approve the continuance of the existing Two Special Circles and Seven Special Divisions for a further period upto 31.03.2023 as approved in G.O.(2D)No.40, Housing and Urban Development (SC1(2)) Department, dated 26.03.2018, RAY cell as HFA cell till 31.03.2023 excluding Steno-Typist Grade-II-1, Typist-1, Technical Assistant-7, Supervisor-7, Project Co-ordinator-1 as approved in G.O.(Ms)No.42, Housing and Urban Development (SC1(2)) Department, dated 22.02.2011 and to create one more post of Chief Engineer, One Special Circle and Two Special Divisions and the Project Monitoring Unit for implementing the World Bank funded Tamil Nadu Housing and Habitat for Urban Poor Programme in Chennai.

12. The Government after careful examination of the proposal of the Managing Director, Tamil Nadu Slum Clearance Board accord sanction for continuance of the existing Two Special Circles and Seven Special Divisions for a further period upto 31.03.2023 with 110 posts only as detailed in Annexure-I and as approved in G.O.(2D)No.40, Housing and Urban Development. (SC2(2)) Department, dated 26.03.2018, RAY cell as HFA cell as detailed in Annexure-II till 31.03.2023 as approved in G.O.(Ms)No.42, Housing and Urban Development. (SC1(2)) Department, dated 22.02.2011 and to create one more post of Chief Engineer, with staff members as detailed in Annexure-III, One Special Circle as detailed in Annexure-IV and Two Special Divisions as detailed in Annexure-V and the Project Monitoring Unit as detailed in the Annexure-VI for implementing the World Bank funded Tamil Nadu Housing and Habitat for Urban Poor Programme in Chennai subject to the condition that all the above sanctioned posts shall be continued till the actual requirement of staff for the Scheme is achieved or 31.03.2023 whichever is earlier.
